This Memorial Day gathering serves as the Foundation’s annual public meeting. The Foundation Bronze Plaque Program was established as a way for families and friends to give permanent recognition to Bay citizens in one central place. Friends of the families and the public are invited to attend the ceremony today and to view the plaques installed on the park footbridge.

YOUNG - COULTON - KERKA FAMILY SIX GENERATIONS OF BAY VILLAGE LIFE



**Cornealius Young, Bradley Rd.
(1930s)**

In the early 1930s, Perry and Edna Young moved from Lakewood to a house at the corner of Bradley and Maple Roads, initiating a long-standing family tradition of residing in Bay Village. At the time, fields occupied most of the surrounding area and a large lily pond was part of the property. Only a handful of neighbors lived on the street. The Youngs enjoyed gardening and sipping Boston coolers—sodas with vanilla ice cream—on the porch steps and in the wooden Adirondack chairs in their backyard. Perry’s father, Cornealius, “the old grandpa,” joined Perry and Edna and also lived in the home on Bradley. Cornealius would often take walks down Bradley, past the local turkey farm to a small general store over the tracks to buy newspapers and cigars.

In 1939, the Young’s daughter Marian, her husband Wilbur Coulton and their sons, Richard and Roger, moved to Bay. Initially, the Coulton family lived in a cottage on Sunset Park and the boys attended Forestview Elementary School. Eventually, Marian and “Webb” built a home on Pinewood Drive, where they continued raising their children who graduated from Bay High in the early 1950s. Webb was an avid fisherman and sailor, and even owned an iceboat. The Coulton family truly enjoyed their years living in the “cottage” community on the shores of Lake Erie.



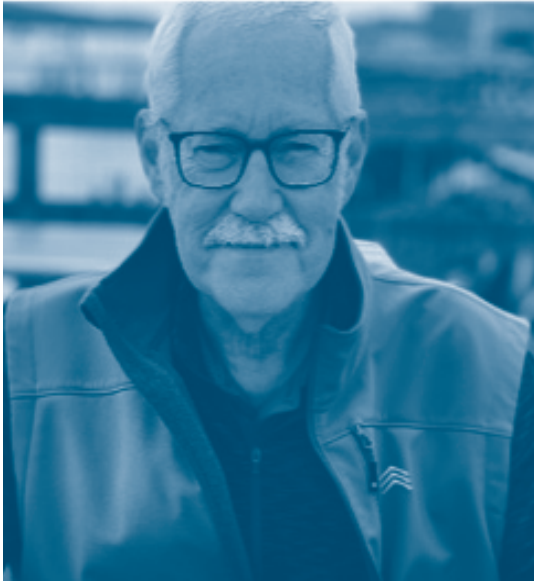
Roger and Richard Coulton, Sunset Park (1940)

After completing college and serving in the U.S. Army, Richard came home to Bay and married seventh-grade teacher, Sonia Strayer. Remaining in Bay Village was extremely important to Richard, so he and Sonia put down roots and raised three children, Anne, Tom and Dan, who enjoyed growing up in, and being a part of, the Bay Village community.

Anne married Thom Kerka and, following in the family’s footsteps, she and Thom bought a home and raised their daughters, Jaimie and Katherine, in Bay. The Kerka girls are the sixth generation of the family to live in Bay Village, and the third generation to graduate from Bay High School.

Nearly a century after Perry and Edna moved to Bradley Road, farms and cottages have disappeared and neighborhoods have grown. Other facets of Bay Village life have remained timeless. Some of the Young’s descendants live less than a mile from their former home and enjoy the same walks, beautiful parks and lakeside activities as the family did in the 1930s.

Dwight Clark



Dwight Clark is not just a resident of Bay Village - he has been an ambassador. With his positive attitude and wit, he has been a role model for many. As an ardent supporter of Bay Village, Dwight has served on several committees and been a member of many organizations including: Bay Village Historical Society, Bay Men's Club (Vice President 1993-94 and President 1994-95), Bay Band Boosters, Bay Rockets Association, Bay Education Foundation board member, co-chair Bay Band Festival (Fall 2005), Chairman of the Citizens for Bay Schools levy campaign (2006), Co-Chair Tri-Bay Golf Outing, ad-hoc committee to repair and replace athletic fields at Bay High School, The Lake Erie Nature and Science Center, BayArts and a founding member of Play-n-Bay. For his duties and involvement, he was named Bay Village Citizen of the Year in 2006 and 2007.

Not a person to sit on the sidelines, Dwight sets his goals to help others. He served on Bay Village City Council as Councilman-At-Large from January 2010 to January 2017. Today, he serves as President of Council. He has also served on various committees within City Council to further enhance the community. Being a cancer survivor, Dwight is an active member of the St. Raphael Men's cancer group. He has helped many coping with similar situations.

Many groups have benefitted from Dwight's enthusiasm, encouragement, and diligence. Beyond Bay Village, he has been a benefactor to organizations that have enriched the Cleveland area, supporting the arts, the environment and the underprivileged.

Outside of enjoying Bay Village citizens and the community, Dwight has been involved in many leisure activities such as golf, tennis, rowing, biking, gardening, and fishing. One of his greatest joys is being able to share these activities with his family: wife Nancy, children Mindy (husband Andrew), Brett and Mackenzie, and three grandchildren Maisie, Fletcher, and Graham. He and his wife enjoy cruising and traveling to many countries.

Dwight was born on April 1, 1957 to his supportive parents Janet and Roland Clark and grew up with two brothers Scott and Jim, in Lyndhurst, Ohio. He graduated from Miami University with a degree in finance. He earned his MBA from Cleveland State University. He met his wife Nancy at Miami University. They married in 1984 and moved to Bay Village in 1985. Since graduating, Dwight has focused his career in banking. He has worked a large portion of his career, 28 years, at National City (PNC). He is currently Senior Vice President serving non-profit organizations at Huntington National Bank.

Jack and Estelle Green

Jack Green and Estelle (O'Connor) Green were born on the West Side of Cleveland; Jack in 1923 and Estelle in 1924. Except for a year in Connecticut in 1951, they lived in Bay Village from 1952 and raised their family there.



Jack and two friends formed an incentive marketing firm Green, Gang and Thibo. He always said he truly enjoyed his work. He was active in St Raphael's Church and with daughter Susan and three sons Jack, Neil and Michael was involved in their social and sport activities.

In his younger years he was a golf caddy and later played golf and tennis with Estelle and friends for many years. Jack was a lifelong member of the Cleveland West Side YMCA and was actively involved in fund raising for the organization, most notably their annual summer golf outing.

Estelle worked as an executive secretary in Cleveland until her marriage to Jack. She was involved since the early years of St Raphael's Church and as a volunteer helped establish and worked in the school library. Estelle was a secretary in the counseling department of St Augustine Academy. She was a member of the Women's Board of the Lake Erie Nature and Science Center. Estelle enjoyed golf and tennis and played both at home and when she and Jack traveled for business or pleasure.

When their children were young, they would vacation at a cottage at Bay Point in Marblehead and invite extended family to visit the Lake Erie beach. The family grew to five grandchildren and five great grandchildren. They built a second home in Boca Grande Florida. There are many happy memories of the family's time there enjoying the beach, pool, sightseeing and boating trips.

In their later years they downsized and lived in Avon Lake. Jack died in 2012 and Estelle in 2021.

For many years they walked these paths appreciating the peacefulness of the lake and changing seasons.

Pamela M. Ebert "Talented Bay Village Artist with a Generous Heart"



Born in Columbus, Ohio, Pamela graduated from Huron High school and earned a Bachelor of Fine Arts degree from Ashland University. In 1972 she married Gary Ebert (of Sandusky), now Managing Partner of Seeley, Savidge, Ebert & Gourash, Co. LPA and together they raised three talented children in Bay Village who have gone on to increase the family numbers: Caroline and Dain Bussewitz of New Albany have added Ronan, Brennan, and Emerson; Amanda and Jon Liskovic of Avon are the proud parents of Avery and Leah; and Brian married Bethany Caldwell in 2021. Pamela is multi-talented. Besides her successful roles as devoted wife, mother, and grandmother, she has taught Art and/or Music in the Rocky River School System, St. Bernadette's (Westlake) and at St. Raphael Catholic School. Her volunteer activities have been and continue to be numerous. She has been involved with the restoration and decoration of City Hall, the Dwyer Memorial Senior Center, and other public buildings, including Rose Hill Museum. Lawrence F. Marsalek (1938-2021) and Carol A. Marsalek (1941-2011)



Lawrence F. (Larry) Marsalek spent all but a few of his 83 years of life residing in Bay Village. His grandparents and parents, Lawrence O. and Ethel Marsalek, lived on Foote Road when Larry was born in August of 1938 at Lakewood City Hospital. Larry's father, Lawrence O. Marsalek, was a music teacher in Bay Village and taught George Steinbrenner piano lessons as a youth. Larry attended St. Raphael's School, Bay Middle School and Bay High School before heading off to John Carroll University in the ROTC program which eventually landed him in New Orleans at Camp Leroy Johnson in 1963 where he earned the rank of Captain in the US Army. During his time in New Orleans he met his wife of 48 years, Carol Ann Kilday, a beautiful and talented southern gal. Carol attended St. Mary's Dominican College to pursue a degree in education and taught first grade at Our Lady of Perpetual Help and St. Pius X Catholic Grade School.

Larry and Carol married in New Orleans in 1963 and moved to Bay Village to create a wonderful life together. After spending 5 years at a medium size manufacturing firm, Larry landed a job with a Japanese owned company, Koyo Corporation, that was just starting up in the U.S. He started as traffic manager and worked his way to becoming an officer of the company during his 35 year tenure.

Carol sold real estate for 12 years so she could stay home with their three young children, Jane, Tricia and Patrick while dabbling in politics. In 1970, Carol became a member of the Cuyahoga County Democratic Central Committee and Executive Committee and was the president of the Bay Village Democratic Club in 1972. She served as a Democratic Ward Leader in Bay Village from 1974-1983. Her passion was politics and she enjoyed an exciting political career working on campaigns for Ron Mottl, Dick Celeste, Jimmy Carter, Francis E. Gaul, Patrick J. Sweeney, William Brown, Kenneth Rocco, Jesse Jackson, Mary Boyle and Sherrod Brown in the 70's-90's. She was the Vice President of the 23rd Congressional District Caucus (1981-1982), Vice-Chairperson of the Cuyahoga Democratic Party (1980-1982) and Jesse Jackson Delegate to the Democratic National Convention in 1988. Carol was featured as one of Cleveland's Most Interesting People in Cleveland Magazine's January 1982 issue.

Above all Carol touched the hearts of all who knew her with her beautiful smile, sense of humor and generosity. She also never shied away from telling you exactly what she thought. Larry enjoyed reading world, US and Ohio history, listening to jazz and big band music, eating food from his Czechoslovakian roots and shooting at the gun range in Avon. He had a soft spot for animals, especially cats and dogs, and was a man with high moral integrity. Carol liked to take photos of nature, paint, go to Heinen's (one of the employees there still mentions missing Carol) and cook delicious southern recipes from New Orleans. Carol and Larry enjoyed raising their family, spending time with their 8 grandchildren and living out their lives in Bay Village near Lake Erie and its natural beauty.

MICHAEL S. KALSTROM (1948-2020)

Michael Kalstrom loved the outdoors ; from his youth,when he accompanied his parents on fishing trips to Canada, to the many canoeing trips he planned for his friends, to hiking trails in the National Parks with his wife Georgia, and skiing trips he took with his two best friends. His religion was inspired by the beauty of nature.

Michael was raised in Westlake and attended Westlake City Schools. He was a graduate of Colgate University. He received his Masters degree in Urban Studies from Cleveland State University.

Michael's love of the outdoors extended to his professional life. He was a member of the National Association of Environmental Professionals and served as a board member of the Ohio Association of Environmental Professionals. He represented Cuyahoga County and served as Secretary of the Local Emergency Planning Committee which was part of the Cuyahoga County Department of Justice Affairs. He was a member of the Ohio EPA Voluntary Action Advisory Committee, the NOACA Hazardous Materials Transportation Routing Task Force Regional Environmental Priorities

Project, Ohio State Emergency Response Commission, and board member of the Ohio Coastal Resource Management Project. He supervised the Cuyahoga County Hazardous Materials Department from 1980 until his retirement.

Michael felt a commitment to civic matters and the growth and prosperity of the city of Cleveland. He was a long standing member of Cleveland's City Club and was past Co-Chair of the Special Programs Committee.

In addition to his love of the outdoors, Michael loved photography and attending outdoor and indoor concerts and live theater. Mike and Georgia attended many theater performances at the Stratford Theater Festivals and the Shaw Festivals. The Kalstroms moved to Bay Village in 1996. They often walked this walking path and admired the lake and its environs. It is befitting that this plaque be placed here in his memory. May his memory be eternal.

ALAN PAULUS



Alan Paulus was born June 14, 1956 (Flag Day) in Midland, Michigan, where he and his four siblings were raised until he left for college. Al graduated with honors from the University of Notre Dame with a Bachelor of Science degree in Mathematics. While at Notre Dame, Al was a manager for various athletic teams, including the 1977 and 1978 national championship fencing teams.

During his high school years, Al met Julie Spyker. They dated throughout college and married in 1978, shortly after graduation.

Al joined the Saginaw, Michigan office of Ernst & Young (EY) in June 1978 and was promoted to partner in 1992, when he and Julie moved their family to Bay Village to join EY's national office in Cleveland. He soon became the firm's National Director of Auditing Standards, where he was involved in the development of the firm's audit methodology and related training materials and the accounting profession's auditing standards. Al moved to the EY Cleveland practice office in 1997, where he provided audit services to such Cleveland based companies as Eaton, TRW, NACCO, Hyster-Yale, Steris, Park-Ohio Industries, and Materion. During his final five years at EY, Al ran EY's Professional Practice—Auditing and Assurance Services Group, which developed and maintained audit policy, methodology, tools, and training for EY's audit engagements.

Al served as a trustee of the Bay Village Foundation for 14 years, including 3 years as its president. During his time as the Foundation's president, Al led numerous efforts to improve our community, including the campaign to refurbish Play in Bay, and helped the Foundation grow to over \$500,000 in total assets. Al also served as treasurer of the Board of Trustees of the Cleveland Play House, vice president and treasurer of the Greater Cleveland Salvation Army, a volunteer for Northcoast Health Ministries and the treasurer of the Cleveland chapter of the Fellowship of Christian Athletes (where he was awarded the Tom Landry Award, for his support of FCA and dedication to youth). Before moving to Bay, Al was actively involved in the Midland, Michigan community where he served on the Board of the Midland County United Way for several years as treasurer, vice president, and president. He also served as treasurer, vice president and president of Family and Children's Services of Midland, and president of the Blessed Sacrament Church parish council. In addition, he was involved in the Boy Scouts (where he was awarded the Exploring Division's Bronze Big Horn Award), Junior Achievement, Leadership Midland, the Chamber of Commerce, and the Rotary Club.

Al and Julie continue to live in Bay Village, and support many community organizations. They are the proud parents of Teresa Heffernan (Kevin) and Katy Coil (Dan) and the proud grandparents of Samantha and Ryan Heffernan and Annie, Patrick and Jacob Coil.

MARIE ASHMUS



Marie Ashmus has been a resident of Bay Village since the 1974. Born and raised in Northeast Ohio, she is second generation Japanese-American and one of Bay Village's first Asian residents. Marie was a teacher in Bay from 1974 to 2008. During her tenure, she taught thousands of kids at Normandy, Westerly, and Bay Middle schools. She was one of the first teachers in the gifted and talented education (GATE) program in the school district and also taught third grade, first grade, and, for many years, kindergarten. So many Bay students got their great educational starts in her classroom! Marie also inspired older district students through the Bay High student aide externship. Through the externship, high school students could receive educational credit for helping a teacher in an elementary classroom. Marie welcomed dozens of high school students into her classroom and many of them ended up choosing education as a career.

Marie's love for teaching is reflected in how adored she is by her former students. Every time she sets foot in any local establishment, especially Heinen's, she is approached by former students and parents and is treated like a local celebrity. She is amazing at remembering her students and loves catching up

with each of them.

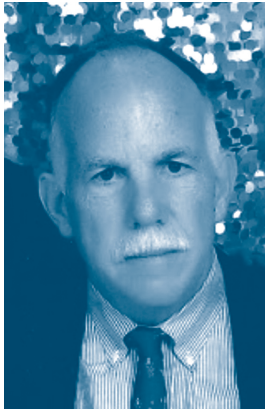
Her expertise was recognized when, after nomination by her students' parents, she became the very first K-12 classroom teacher to be named the Outstanding Alumnus of the Michigan State University College of Education. Every previous recipient of the honor had been a college professor or researcher, but Marie focused the spotlight on the teachers who apply creative and effective methods to classroom education.

Marie's commitment to the community extends to her family life. Her husband, Keith, is a founder and longtime supporter of the Bay Village Foundation and her two kids plus her niece and nephew graduated from Bay High School.

In 2018, Marie was diagnosed with Multiple Systems Atrophy, a rare disease that interferes with the ability of the brain to manage the functions of the body that most of us take for granted—regulating blood pressure, balance, walking, swallowing, hand and finger coordination, digestion, and on and on. JAMES H. CAHOON



James H. Cahoon was born and raised in Akron, Ohio (02/04/1954). He graduated from Washington and Jefferson College (1976), where he was a four-year football letter winner, twice president of his fraternity, and member of Who's Who in American Colleges and University. He holds a Master's Degree from the University of Akron (1990). Jim has lived his adult life by the axiom; "Happy is the man who dreams dreams and is willing to pay the price to see those dreams come true." He taught Social Studies in the Akron Public Schools for thirteen years, where he coached football, girls' cross country and track, girls' basketball and softball. His sports teams won eighteen city series championships, eight district championships and two regional titles. He is a member of the Summit County Sports Hall of Fame.

Jim moved into school administration in 1989 when he became Coordinator of Pupil Services in Akron, then High School Principal eventually becoming Superintendent of Black River Local Schools. Cahoon's career was capped off beginning in 1999 as Principal of Bay High School, where he served for twelve years. Principal Cahoon was extraordinarily proud of his teachers and students during his tenure. Bay High was frequently ranked among the best in the country in Academics (particularly AP), Music and Athletics. Some highlights of Jim Cahoon's career at Bay High include the school earning Blue Ribbon School Status

in the fall of 2010, beginning YPF (Youth Philanthropy Fellowship), a group of students, who raised money for health charities, starting HUDDLE (Helping Us Develop Dedication Leadership and Enthusiasm), a role model program, where students from the high school would teach life lessons to 2nd, 4th and 6th graders and helping to start PAL (Pupil Assisted Learning) with Brian Routhouska, which was a Typical Peer Friendship Program with Special Education Students, and formalizing Rocket Cards (People will forget what you said, people will forget what you did, but people will never forget how you made them feel-Maya Angelou).

Jim Cahoon was a student centered principal, who hoped the high school was a place where each student felt safe and could achieve to his/her fullest. He has forever referred to Principal of Bay High School as the greatest job he could ever have. Jim is happily married to Dr. Debra Dodez Cahoon. They have three children, Kyle, Erin and Kate. They have been blessed with five wonderful grandchildren. Jim loves to play golf, attend music concerts, follow Cleveland/Bay Village sports teams, volunteer and travel the world with his wife. He is a Vice Chair of the MetroHealth Foundation Board and has chaired golf tournaments for MetroHealth's Cancer Center (Brett Altieri Memorial), Fill This House, Care for Aids and With Love, Maggie. Cahoon has stayed involved in Bay Schools during retirement with OCAD (Our Children Are Dying), PreVenture, the We Care Committee and the Bay High School Athletic Hall of Fame, which he helped found with Jack Rekstis. Jim and Deb recently moved to Eatonton, Ga, but Bay Village and Northeast Ohio will always be home.

Each year at BAYarts' annual fundraiser Moondance, a person (or people) who has made a difference in the community and in the arts gets a chance to "shine in the moonlight." On Sept. 14 this year, BAYarts will honor Gary and Pamela Ebert, who individually and together have contributed a lifetime of service to Bay Village and to BAYarts' continuing expansion.

In 2006, when BAYarts was forming a new board and hurdling other challenges, Gary stepped up with legal counsel and a genuine interest in seeing the new organization succeed. He has remained on the board ever since (only occasionally leaving a meeting early for another city meeting or a grandchild's sporting match). Pam was the creative force behind BAYarts' sold out ENCORE! last year, a benefit for the playhouse renovation, raising twice the targeted funding goal (while making it look incredibly easy).

Together, the Eberts are benefactors of BAYarts' historic red caboose, a passion project, funding renovations and upkeep over the years and dedicating it to their grandchildren.

Gary and Pamela graduated from Ashland University and moved to Cleveland so that Gary could attend law school. They moved to Bay Village in 1976 where they raised their three children – Carrie, Amanda and Brian – and immediately became very involved in the community. Although he recently retired from the city, he remains a consultant and keeps up with his busy law practice. He is on the leadership council of St. John Medical Center, a trustee for "Wigs for Kids" and, in addition to BAYarts, is on the board of directors for the International Municipal Lawyers Association

They attended rival high schools on the northwest side of Chicago and met while attending Wright Junior College after Frank returned from serving 3 years in the Air Force during WWII which included a visit to Normandy, France 5 days after D-Day.

After a year at Wright Frank left Chicago to attend the University of Iowa where he played football for 3 years and graduated in 1950 with a degree in business. On December 26th of that year they were married in a blinding snowstorm, but it must have been a good sign for the marriage lasted over 66 years! Bob, nicknamed Beet by his older brother, was the second of three boys born to Robert L. and Agnes Fleming of Seven Hills, Ohio. A member of Beta Theta Pi fraternity, Bob graduated with a degree in mechanical engineering from Case Institute of Technology in Cleveland in 1961. He worked at NASA Lewis Research Center on the Saturn V and introduced himself to his Cahoon Road neighbors with a moon landing party in July 1969.

A founding father of the Cleveland Fagowee Ski Club, Bob met Nancy (Majercak) at a club meeting in 1972. Nancy was the second of four children born to Edward and Nancy Majercak in Lakewood, Ohio. “Beloved photographer, businessman, citizen, and friend”

Born on Cleveland’s east side, Bob graduated from Shaw High School and earned a Bachelor of Science in Business Administration and Master of Business Education from Bowling Green State University. In 1970 he married Monica Roman and returned to Shaw High School to teach Distributive Education, at the same time starting the Retailing Program at Ursuline College in Pepper Pike. Shortly thereafter he left education to work for Republic Steel in Manpower Planning and Development; he moved on to the Personnel Department of Allied Supermarkets and finally to Bowman Distribution as Corporate Training Director. This last position had Bob travelling throughout the U.S. and this definitely took time away from his wife and two young children, Stephanie and Bobby.

As a teaching assistant at BGSU, Bob had dabbled in photography for supplemental income and that interest had grown through the years; so in 1986 he and Monica teamed up and established Thomas & Thomas West Shore Studio, Inc. in Bay Village, which they had called home since 1977. It quickly became one of Cleveland’s most respected studios. The studio was sold in 2009 to two talented young women who had had their own high school senior pictures done by Bob. The legacy continues.

Bob’s photographic artistry continues to grace many homes in Bay Village and throughout NE Ohio. He was an exceptional talent, recognized by the Professional Photographers of Ohio as “Mid-East Regional Photographer of the Year” in 1995. One of his best known photographs (“All My Children”), a delightful portrait of nine Irish Setter puppies, hangs on permanent exhibit in the Photography Hall of Fame in Oklahoma City. His favorite subjects, however, were the hundreds of high school seniors he photographed yearly. He was able to see the best in each of them.

Besides his business endeavors, Bob served on the Red Cross Executive and Blood Committees, organized the first all-high school blood bank this side of the Mississippi, served as Bay Men’s Club President (1989-90), and in 2004 became a “walking” volunteer for SOAR, an organization that provides recreational opportunities for adults with disabilities.

Bob, a multi-talented man, with a kind, gentle heart often remarked that he had received so many blessings: a devoted family, faithful friends, and living and working in Bay Village.

(1928-2013)**



John L. Yuhas, Sr., was born on August 13, 1928 in Lakewood, and attended Saints Cyril and Methodius School while growing up in Lakewood's "Bird Town." His mother died when he was two years old, and John benefited from programs at Lakewood Day Nursery, which provided structured activities to motherless children. The experiences there formed the foundation for his life's work in elementary education and recreation.

John graduated from Lakewood High School in 1947. He was a three-sport letterman in football, basketball, and track. He was the Ranger's leading scorer in basketball in both his junior and senior seasons. After graduation, John worked for the Lakewood Service Department and attended Ohio University briefly before being drafted into the Army in 1950.

While in the Army, John was assigned to special services. He worked providing recreation activities for the troops at his base. He also participated on the Camp Breckinridge football, basketball, and track teams. Participation on these teams allowed him to travel around the country and play against many All-Americans and professional players of that era. Just prior to his discharge from active duty, he played in the 1953 Salad Bowl in Phoenix, Arizona, the precursor to today's Fiesta Bowl. He then served as an Army reservist until 1957.

John returned to college and graduated from Ohio University with a B.S. in education in 1957. Soon thereafter he started his thirty-year career as an elementary physical education teacher for the Berea City School District. While working as a summer baseball league

coordinator at Lakewood's Madison Park, John met Rosemarie Siemer, and they subsequently married on May 30, 1958. They moved to Bay Village and lived there for the next 47 years. They had four children; John L. Yuhas, D.O. (Kimberly) of Fremont, OH, Monica Mack (Frank) of Mechanicsville, VA, Jay Yuhas, D.O. (Michele Moore, D.O.) of Bay Village, and Jennifer Ponce (Roberto) of Farmington Hills, MI. Their ten grandchildren are Mike, Amy, Eric, Carolyn, Annemarie, Steven, Patty, Cyril, Isabella, and Carmen. He was an excellent role model and ardent supporter of all of his children and grandchildren. In recent years, he reveled in attending his grandchildren's Olympic Day at Normandy School, and was noted by parents, teachers and staff to be in his element.

While starting his life in Bay Village, he maintained his athletic career and Lakewood roots. John and his Lakewood buddies won the 1959 World Slow Pitch Softball Tournament sanctioned by the Amateur Softball Association of America. The demands of family life and a sore knee brought his playing days to a close, so he began to work after-school hours and summers with the Bay Village Parks and Recreation Department. He was the commissioner of the Early and Bay Major Softball Leagues at Cahoon Park. There he enjoyed interacting with many players, umpires, maintenance crews, spectators and the children who liked to hang out at the ball fields. For many years, John's golf classes were popular among many Bay residents as well. For over 25 years, he volunteered for the Bay High School Football Chain Gang.

During John's residence in Bay, he was a parishioner at St. Raphael and then Holy Spirit Catholic Church. Over the years, he moved his family to several different homes in Bay, restoring and maintaining them with great pride. He always meticulously planned and planted vegetable and flower gardens. Jim earned a BS in Economics from Purdue University (1955-59). Jim played football for Purdue successfully and went on to play for the Boston Patriots briefly. He married his high school sweetheart, Elizabeth, in 1961, and had five children. All children attended and graduated from Bay High School. How appropriate it is that this dedication plaque will be located just down the road from where Ivan and Miriam Shepard lived on Lake Road in Bay Village for over 50 years. Their beautiful home, which overlooked the lake, is where their love grew, where they raised their three children, and where the center of most activity occurred for their family, which included eleven grandchildren, and recently two great-grandchildren. It was home where they taught mainly by example through loving guidance to their children the virtues of kindness and wisdom, which formed the children to see the presence of God in all. Their home was a place where the fondest memories were of just having fun with loved ones.

Miriam was born in Perth Amboy in New York and raised in East Sparta, Ohio. Ivan was born and raised in Agawam, Massachusetts. Miriam and Ivan met in 1949. He had returned from naval service in World War II in the Pacific and was a student at Ohio State University. Miriam had just graduated from the same university, where she was also a student. Miriam had been selected as an OSU sorority beauty queen while a student and caught the eye of Ivan. They married in 1950, lived in Columbus, Ohio, and subsequently had three children, Kirk, Robin, and Mark. The family moved to Bay Village in 1962, when Ivan, an insurance executive, was asked to start a new company in Cleveland. The Shepard family fell in love with the century home with the large porch overlooking the lake and purchased it. The house was built in 1880 and proudly displays a plaque presented by the Bay Village Historical Society, which hangs near the front door. The plaque signifies that the house was one of the original homes in Bay Village. The white clapboard home was just right for both: Ivan with his love of nature and the lake's many scenic presentations and Miriam with her love of decorating, cooking, antiques, and the space to create a warm family setting. In the past, Miriam even served as president of the local antique club. The home was also the perfect setting to raise their three growing children; eventually all three would graduate from Bay High School. Two of their three children returned to Bay after college and are currently raising their own families in the community. Even though Ivan and Miriam participated in many activities within the community, schools, work, and the church, nothing supplanted the importance of family as the center of their lives. And in return, "Mimo" and "Pepe" (as they were fondly called by their grandchildren), have always been in the center of the lives of their three children, their spouses, and their grandchildren.

She not only raised funds and handled publicity, but she also came up with ideas for League events. Her "Let's Vote" project of Mock elections at the Bay Village Middle School was the model for Mock elections at High Schools around the County by LWV Cuyahoga Area. Candidates Nights and Voters Guides always received her meticulous attention. She worked very hard lining up workers for Bay Days and the Bay Chapter's part in that. The Board of Education recognized her contributions at Candidates Night 2011 with a tribute and a plaque that hangs in the Middle School library. The inscription reads "In memory of Joan Hirsh. We honor her years of service in Civic Education to our Bay Village students and the community with the League of Women Voters."

Her death on August 30, 2011 was unexpected and mourned by all who knew her.

Tom served on dozens of Boards, Commissions, and Committees, the majority geared towards improving the lives of people of all ages in Bay Village and elsewhere.

The O'Neills married in 1951. Alva worked downtown in the Terminal Tower for the Cuyahoga County Park Board during the exciting time of park expansion, now known as the Emerald Necklace.

John was a Carpenter and worked for several large contractors such as MJ Boyle of Chicago as a foreman building the Nike site in Cleveland.

T. RICHARD MARTIN



T. Richard Martin was born in Cleveland, Ohio and graduated from John Marshall High School where he excelled in track. He attended the University of Wisconsin, graduated from their School of Commerce, and was inducted into the Iron Cross Society Honorary.

After college, Dick married Betsy, a fellow University of Wisconsin graduate. They honeymooned while Dick served stateside in the Army in the Military Police. They moved to Bay Village in the late 1950's to the house they currently call home. They welcomed daughter, Susan and son, Ross.

Dick Martin was appointed to Bay Village City Council in April 1967 to replace Donald Gresham, who passed away in March 1967. Dick was re-elected thereafter for two year terms beginning January 1, 1968 through January 1, 1990. He was elected to the office of President of Council for the term beginning January 1, 1972 and every four years thereafter.

In the mid 1990's, City officials and citizens alike realized the need for a private foundation in Bay Village. With help from then Mayor Tom Jelepis and Law Director, Gary Ebert, the charter for The Village Foundation was written. In 1995, Dick Martin, Wayne Reese and Tom Jelepis signed the

Articles of Incorporation. The Founding Trustees of The Village Foundation elected Dick Martin, President.

The mission of The Village Foundation is to preserve the quality of life in Bay Village, Ohio by using the talents and resources of private citizens and non-government funding. The Village Foundation exists to provide support for projects and programs fostering Bay Village's social, historical, cultural and educational heritage.

Dick is the leading contributor to The Village Foundation with many of his donations made in honor and in memory of outstanding citizens who dedicated much of their life in the service of the City of Bay Village.

T. Richard Martin has had an enormous influence on the Bay Village we know today, demonstrating a love of community, willingness to serve and dedication to the future that is rarely seen. We will all reap the benefits of his vision for years to come.

DAVID HENRY JACOBS (1921-1992)



David Henry Jacobs was born in Akron, OH on May 4, 1921 and graduated from Buchtel High School.

During World War II, he served in the Naval Lighter Than Air Squadron from which he was honorably discharged in 1945 as a Lieutenant Senior Grade. He is a graduate of Indiana University and obtained a degree in Business Administration in 1947. As a young man seeking employment in Cleveland, he made his home at the YMCA. He developed a fondness for the organization and subsequently became one of their financial supporters. He met Barbara M. Barrow at Indiana University. They married in 1948 and had three children: David Henry, Jr., Marie Desire and John Walter. They are all graduates of Bay High School.

Over the years, together with his brother Richard, they founded their company, The Richard and David Jacobs Group, and compiled a portfolio of major developments and properties throughout the country.

In December 1986, David Jacobs became an owner and Vice Chairman of the Cleveland Indians. The team embarked on a major revitalization that included the opening of the new ballpark in 1994 in Cleveland's

Gateway development complex known as Jacobs Field.

During his career it mattered to David that things were going well with his employees. He was a very personable man and chose to park in the employee parking lot in order to maintain contact and communication.

The world was a better place with David in it and he continues to be an inspiration to many.

DEL DONAHOO



Feature reporter Del Donahoo travels throughout Northeast Ohio in his "Folkswagon" to cover people, places and events for WKYC, Gannett's NBC affiliate in Cleveland, OH. He is best known for his "Del's Folks" and "Del's Feasts which spotlight people and dining places.

In November 2003, Del turned 80 years young, celebrating 34 years at Channel 3. In 1993, he was honored with a Silver Circle Award from the Cleveland Chapter of NATAS for 25 years of service in broadcasting. In 1990, he was inducted into the Ohio Broadcasters Hall of Fame. On his 65th birthday, the mayors of 116 towns/cities across NE Ohio proclaimed it Del Donahoo Day.

Del co-anchored the live morning show "Today in Cleveland" weekdays at 6:30 AM with Tom Haley until June of 1997. During his years with Channel 3, Donahoo served as a general assignment reporter and news anchor. Before joining the Cleveland's NBC News Bureau in 1968, he was a news/feature reporter for WDAF-TV Kansas City, MO for seven years. Del previously worked at WOW-TV/Radio in Omaha and WSUI Radio in Iowa City while attending the University of Iowa.

Del and his wife Martha are both Iowa natives. Del is proud to have been born and raised on an Iowa farm near Moravia. They reside in Bay Village and have two children, four grandchildren and a cat named "Cookie".

FREDERICK FRANCIS DRENKHAN



Cleveland native, Frederick Francis Drenkhan was born November 1, 1926 and moved to Bay Village, December 7, 1941. He graduated from Parkview High School, Bay Village Class of 1944. Fred served in the U. S. Navy from 1944-1946, serving in the Pacific, Japan and China. In 1948, he joined the City of Bay Village Department of Police and served as its Chief from 1965 to 1976. Continuing his law enforcement career, Fred served as the Executive Director of the Cuyahoga County Police Chiefs Association from 1976 to 1985.

Throughout his honorable and distinguished career, he is remembered for innovative and ongoing programs. In 1972, while serving as Bay Village Chief of Police, the Bay Village Youth Commission was created. The Youth Commission's purpose continues to assist "first time offenders" involved in acts of juvenile delinquency.

Fred was instrumental in the creation of the Westshore Enforcement Bureau (WEB), a formal Council of Governments involving six communities to share resources of equipment and manpower with disasters, criminal activity and investigations. The WEB concept has been adopted by many of the communities in Cuyahoga County.

While serving as the Executive Director of the Cuyahoga County Police Chiefs Association, he represented sixty-one county police departments. He was instrumental in the development of the Cuyahoga Regional Criminal Information System (CRIS), a central criminal history file. He also created and served as the coordinator of the Cuyahoga County Crime Stoppers program. He published a monthly bulletin called "Chiefly Chatter" as well as editing and publishing a magazine called "Police Chiefs in Review" which featured every police department in the county and its history.

In 1992, Fred received the "Man of the Year" award from the Cuyahoga County Police Chiefs Association. He married Johanna in 1951. Together they have three children, Diane M. Barnes, Springfield, MA, Bay High class of 1972, Leeann F Nemec, Strongsville, OH, Bay High class of 1974 and Fred G. K. Drenkhan, Bay Village, OH, Bay High class of 1984. Fred and Johanna have six grandchildren. Fred has served his community well as employee, volunteer, friend and neighbor. Bay Village, its residents and institutions, have always been a high priority for Fred.

BRADLEY HOWARD FRIEDEL



Bradley Howard Friedel enjoyed playing many sports as a young boy, but soccer caught his eye and his heart at the age of six. He represented the Bay Soccer Club and played on a travel team called the Bay Firecrackers, and helped the Firecrackers earn one of the most outstanding records in the State of Ohio. At Bay High School, he sharpened his goalkeeper skills and played goalkeeper on a select travel team known as East-West.

Brad's athletic skills were not limited to soccer. At Bay High, he earned eleven varsity letters as a three-sport athlete. He was named MVP in Soccer; Third Team All Ohio in Basketball; First Team Greater Cleveland Soccer; Basketball, Southwestern Conference Champion and Bay High's Boys Tennis. He also participated in Show Choir and was selected for National Honor Society.

Following graduation from Bay High, he attended U.C.L.A. and earned many awards, including Soccer America Freshman of the Year and the Adidas Goalkeeper Golden Boot Award (as the nation's best male collegiate goalkeeper). During his senior year, he received the Hermann Trophy as the Best Male College Player in the United States.

Brad played on the U.S. National Team since 1992, and as a World Cup team member. In 2002, he was selected as the starting goalkeeper for the World Cup team.

Brad's professional career began in 1994 when he played for Nottingham Forest in England. Since 2000, he has played for the Blackburn Rovers in England and was named Goalkeeper of the Year, England, in 2003. Brad became the first American picked for the English Premier League Team of the Year when he was voted the top goalkeeper by his fellow players.

Brad's parents, Sue and Len Friedel (Len, a Bay High graduate, class of 1961) and his sister, Kimberly Friedel Loveless (class of 1986) share pride in Brad's accomplishments. Brad and his wife, Tracey, are expecting their first child. Brad has always remembered his hometown, and he gave a heartwarming speech at Bay High's 2000 homecoming. He said, "I have traveled to many places in the world, but it is always good to come home."

GRACE McGAHAN MATTHEWS (1918 - 2002)



Grace McGahan Matthews was born in Cleveland, but moved to Lakewood at the age of four. After graduating from Lakewood High School, she completed the requirements for graduation at secretarial school. Grace was employed by Sweeney and James, an advertising company, where she was secretary to the partners. She married Edward Matthews in 1944 and put her career on hold with the arrival of their son, Craig.

Grace thoroughly enjoyed motherhood, and found herself immersed in PTA work. After several years of commitment, she became president of Forest View PTA and later vice-president of the PTA for the new intermediate school.

She resumed her business career by returning to Sweeney and James and, after several years, became president and majority owner. Grace retired in 1985.

Grace devoted many hours to community service. She was an active member of the Cleveland Women’s Advertising Club and the Cleveland Woman’s City Club, as well as a member of the Bay Village Women’s Club. She enjoyed travel, including two trips to Europe. She lived in Bay Village for 55 years and would not have considered leaving.

RUTH HART AND ROBERT STROMBERG



Ruth and Bob moved to Bay Village in 1946 and built one of the first new houses on Longbeach Parkway amid the cornfields and vineyards. Glenview School opened in 1947 and their oldest daughter, Carol, was in the first kindergarten class. They also served on the original fundraising committee for St. Barnabas Episcopal Church. In the mid-fifties they left Bay Village, but returned twenty years later to live out the rest of their lives.

Ruth Hart Stromberg was a lawyer when there were few women in the profession. She graduated from Lakewood High School, Miami University and in 1937 from Western Reserve University Law School. She worked as a legal editor and then a legal librarian for several law firms. When they moved to Washington, D. C., she worked at the Library of Congress doing legal research and then for the Department of Labor. Eventually, she became an assistant to the Secretary of Housing and Urban Development. When they returned to Cleveland, she was the first woman to serve as an assistant law director for the City of Cleveland under Mayor Carl B. Stokes and later specialized in discrimination cases for the Department of Labor before retiring in 1975. In addition to her legal career, Ruth was a published writer, served on

numerous civic and charity boards and was a PTA president in Rocky River.

Robert W. Stromberg graduated from Rocky River High School, studied mechanical engineering at Purdue University and finished at Case Institute of Technology. One of his early jobs was with National Carbon Company in Cleveland where they were helping to produce parts for the Manhattan Project. Bob was also active in several Masonic organizations, chaired many school levy campaigns, was treasurer of the Bay Boat Club and was the first treasurer of the Rocky River American Field Service chapter. After Ruth died in 1990, he delivered Meals on Wheels and became a volunteer grandfather for a fourth grade class at Westerly School. He helped the students with reading and math skills and often researched and prepared presentations to make their learning come alive.

Ruth and Bob loved Bay Village and always considered it home. They never missed a Memorial Day parade. Their house was a mecca for the grandchildren and their friends, many of whom learned to swim in their pool. They attended school and sports activities often and worked to represent senior citizens in every school levy campaign. They were married for 50 years and taught, by example, that love is the ultimate value in life.



LAURIE ANN WILDER (1964-1984)

Laurie Ann Wilder was vibrant; the sound of her distinctive laugh resonated through the hallways of Bay High.

She was spirited. Because of her lively, eager character, she was the energy that drove the activities in which she was involved. Laurie was also “spirited” in that she was infused with the energy of her faith.

Laurie had no self-imposed limits. Nothing, not even Cystic Fibrosis, stood in the way of her dreams. Despite the physical challenges of her disease, Laurie was a cheerleader, cross country runner and sailor.

She was an achiever. In addition to the physically demanding activities of her athletic involvement, Laurie also participated in Student Council, National Honor Society and Young Life. In the fall of her senior year, the student body elected Laurie Homecoming Queen of the Class of 1982. She excelled academically and made the Dean’s List in her last semester at Bowling Green State University.

Laurie’s courage and faith touched everyone who met her. As a member of Delta Gamma Sorority at BGSU, she inspired her sisters as she did her classmates at Bay with her unwavering

affirmation of life.

Laurie was the daughter of Mr. and Mrs. Harold Wilder. Although diagnosed with Cystic Fibrosis when she was six months old, she never allowed her disease to define her or limit her. She died on April 20, 1984 after 20 victorious years of life.

Those who knew her, loved her. Those who remember her, miss her. We celebrate a life that continues to be an inspiration to us all.

JAMES H. COWLES (1927-1999)

Cleveland native James Cowles graduated from John Marshall High School and served in the Navy’s Amphibious Corps during World War II. He worked part time with the Bay Village Police Department in 1950 and became a full-time patrolman in 1951. He was instrumental in modifying the department’s FBI training program and instructing fellow officers in the use of weapons. Because of his height – 6 ft. 6 inches – and because of his commanding presence, he was often compared to the legendary Tennessee sheriff Buford Pusser, whose folk hero image was played out in the movie Walking Tall.

For 27 years, James served as the lieutenant in charge of the detective bureau until 1977, when he made the decision to run for Mayor. He ran as an independent and won the election.

The newly-elected mayor demonstrated a management style that made him highly successful. He spent time working alongside city employees in each department in order to better understand how they operated, what issues they were facing, and what he might do to help solve problems. He went on calls with the Fire Department and on inspections with the Building Department. He even rode on the garbage truck as it followed its trash

collection route.

His generosity and willingness to be involved was well known and respected. He often helped pump water from the flooded basements of residents who called with complaints. He purchased an industrial strength snowblower with his own money for use in his neighborhood.

In May, 1988, James resigned as mayor and he and his wife, Bette, moved to Ocala, Florida. Two years later, they returned to become residents of Avon Lake. In retirement, his leadership qualities were still evident. A lover of golf, he worked as a ranger at Bob-O-Link Golf Course. He was also a member of St. Raphael Catholic Church and the American Legion Post 211.

James and Bette were married nearly 55 years and were parents of six children. His legacy of service lives on in the memory of others and in the community at large.

HARRY J. EBERT (1917-1995)



Harry Ebert was born in Sandusky on February 13, 1917. He grew up in St. Mary’s Parish and later became one of the most influential persons to work to benefit education and sports. He married Virginia Westerhold in 1945 and they had three children: Nancy Spelman, Gary Ebert and Neal Ebert. Harry served in World War II with the navy in the South Pacific.

Harry worked in a local business, Brohl and Appell, and later became its president and owner. He was very involved in the community. He was in Kiwanis, Knights of Columbus, Chamber of Commerce and Amvets for many years. His love of sports helped him create many teams for the youth of St. Mary’s. During his life he started girls’ basketball, girls’ softball and boys’ baseball programs at the school. He coached the Babe Ruth League for many years and started boys’ baseball at the Ohio Sailor’s and Soldier’s Home. He was on the Board of Directors until his death in February of 1995. He was a major influence in local politics and helped encourage many local politicians.

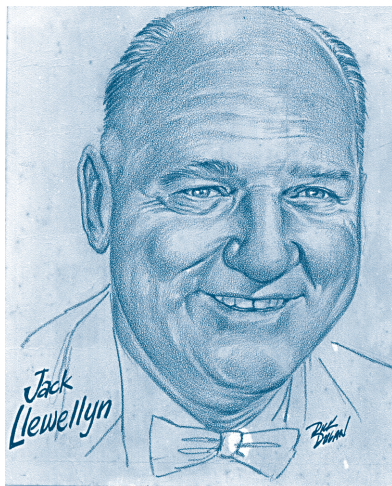
WAYNE E. WENTZ (1922 - 2000)



Wayne Wentz was born in Kenton, Ohio on May 19, 1922. He spent most of his youth on the family farm and met his future wife, Geraldine Conaway, in Kenton. They were married in 1943 and had three children: Pamela Ebert, Eric Wentz and Elizabeth Wentz. He served in the Army during World War II and moved to Columbus and graduated from The Ohio State University.

The Wentz family moved to Sandusky and Wayne spent many years working for Barr Rubber. He was involved in many organizations, including the Junior Chamber of Commerce, Kiwanis and the Masons. He moved to Huron and raised his family, continuing to be involved in local organizations. He enjoyed golf and loved to travel. During his travels, he developed an interest in antiques, which he collected for the rest of his life. He was very active in the Huron Methodist Church until his death in March, 2000.

JACK WESLEY LLEWELLYN (1915-1993)



Jack Llewellyn was born July 7, 1915 in Akron, Ohio. He graduated from Lakewood High School in 1933 after receiving letter awards for two years in football, basketball and baseball. He proceeded to Miami University in Oxford, Ohio and graduated in 1937.

Jack excelled in football at Miami, participating as a member of the 1936 Buckeye Conference Co-Champions and is best remembered for kicking the winning field goal to defeat Ohio University during their championship season.

After graduating from college, Jack continued his football career playing professional football for the Chicago Governors and the Dayton Roses, and in 1942 enlisted in the United States Navy. He served aboard the U.S.S. Thurston and participated in the Navy V-5 and V-12 programs. He completed his service in February of 1944.

Jack moved to Bay Village in 1946 and successfully began his teaching and coaching career. He was an outstanding teacher, coach and mentor to the youth of the city for more than 25 years, beginning in 1946 until 1971. His efforts and dedication helped mold the early years of so many to help prepare them to face the challenges of life. His record speaks for itself, and includes: a record of 153 wins, 49 losses and 14 ties; nine Championship / Co-championship teams; President of the Greater Cleveland Football Coaches Association (GCFCA) for two terms; recipient of the GCFCA Coach of the Year award for two years; honored by Cleveland Touchdown Club, Special Award 1970; and elected to the Ohio High School Football Coaches Hall of Fame in 1978.

Jack also initiated the Fellowship of Christian Athletes in 1966 and was instrumental in starting the Bay Rockets Association which today offers support to all athletic programs at Bay High School. In addition, he started and formalized many activity programs now domiciled in and managed by the City Recreation Department.

Jack Llewellyn truly had a major impact on the formation and development of the City of Bay Village through his unselfish dedication to its citizens.

JOHN HARRISON PARKER (1935 - 1998)



John Parker was born in Lakewood, Ohio on November 29, 1935, but at age nine was shocked to learn that his family was moving to "rural" Bay Village. John had to trade the adventure of riding the Clifton streetcar to elementary school for "cows, vineyards and new kids." A Bay Village resident for the rest of his life, he graduated from Bay High School (class of 1954) and Denison University (class of 1958).

John was a 21-year-old life guard at Huntington Beach when a diving accident left him paralyzed from the chest down. Not only did he withstand the accident, he overcame it with incredible grace. He ground his way through Case Western Reserve Law School, passed the bar exam, established a private law practice, married his beloved Carol, adopted and raised the two children he adored, became president of Bay Village City Council, and endured the additional traumas of the accidental death of his fifteen-year-old son, John, and the tragic death of his father.

In addition to practicing law from a home office, John hosted Bay High students there to discuss career opportunities in the legal field and shared with them the issues associated with living with a disability. In 1991, he was voted Bay High School Distinguished Alumnus for his continued support of the community.

John was a charter member of the Bay Village Jaycees and was voted Jaycee of the Year in 1966. In 1968, he was selected as one of the Outstanding Young Men of America by the Outstanding Americans Foundation.

John served as a city councilman and as a council president "BE" (before elevators). His fellow council members, as well as members of the Bay Village police and fire departments, physically lifted John in his wheelchair up the many stairs to council chambers and then back down at the end of the meetings. His gratitude and the eagerness of friends and family to help enabled him to pursue his dreams and to achieve his goals. A neighbor wrote of John, "What I always admired about John was how much he had to overcome, and yet, he was one of the least handicapped people I knew."

DALE A. SMITH



Dale A. Smith served as a city councilman in Bay Village for five years before being elected Council President. His years as Council President spanned several decades. A graduate of Ohio Wesleyan, he and his wife, Martha, settled in Bay Village and had a daughter, Sally, and a son, John.

Dale worked in the Trust Department of Central National Bank. He applied his financial skills to his work as the city's first Finance Director. While he stressed economy in government, he believed it is sometimes more economical to spend wisely than to be shortsighted and miserly. He recognized the future needs of the small community of Bay Village and stressed planning that would address and meet those needs. He proposed improvements in disposal methods, safety protection and road programs. He believed that solutions must benefit the city as a whole, not a small pressure group.

Dale was a charter member of the Bay Boat Club and past president of the Bay Men's Club. In retirement, he sat as a model for artists in the Baycrafter's spring portrait courses. He was selected as the model because "his face is the face of everybody's grandfather," according to the art students.

Some people who consider service to the community to be important receive applause, fanfare and parades. Others, like Dale Smith, serve quietly and consistently to shape the future of Bay Village.
